**Conditions:**

1. College has to submit the compliance report of suggestions made by Inspection Committee at the earliest.
2. Future affiliation will be renewed subject to fulfilling the recommendations/conditions suggested by the inspection committee.
3. The intake capacity that is number of students to be admitted in the first year of **B.Sc. (Hons.) Agriculture** programme shall not exceed 60 and that the affiliation would be restricted to the academic programme only upto level of under graduate education for the academic session 2023-24. The students shall only be admitted through JET to be conducted by State Agricultural Universities of Rajasthan rotationally. After admission process have completed, a list of admitted students in **B.Sc. (Hons.) Agriculture** shall be submitted to this University by the college.

**Suggestions:**

1. College administration must have to create their own infrastructure and land for college building and instructional farm.
2. There is an immediate need to upgrade laboratories with equipment according to ICAR guidelines, procurement of more books in the library, development of sports facilities, strengthen internet connectivity, initiate and NCC/NSS unit and implement a biometric attendance system in the college.
3. Construction of strong room for keeping examination papers.
4. The college should transition to digital payment for staff salary and lease installment in future.
5. Development of instructional farm for different practicals.
6. Development of experiential learning units as proposed by the 5th Deans Committee
