- (ii) Registration with Ministry of Environment and forest/Central Pollution Control Board/Rajasthan State Pollutions Control Board/any other state pollution control board etc. regarding disposal of e-waste.

4. Period of validity of Bid:

The bid shall remain valid for 90 days after the date of bid opening. If any bidder withdraws his tender before the said period shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security/Earnest money absolutely.

5. General Terms and Conditions:

- (i) The Book value of the items is **Rs. 34,04,097/- (Rupees Thirty Four Lakh Four Thousand Ninety Seven Only)**
- (ii) GST as applicable at the time of auction shall be charged extra by bidder as per rules.
- (iii) Each page of tender document should be signed by the bidder(S) in token of acceptance of terms and conditions of tender.
- (iv) Incomplete and unsigned quotations are liable to be rejected.
- (v) Tender form attached with this Tender Notice as Annexure "A"
- (vi) Details of obsolete items are as per Annexure "B".
- (vii) The successful bidder needs to sign an undertaking mentioned in Annexure-A that all the e-waste will be disposed-off as per e-waste (Management and Handling) Rules,2011 notified by ministry of Environment and forest.
- (viii) An Earnest Money Deposit of **Rs. 68081/- (Rupees Sixty Eight Thousand Eighty One Only)** must accompany each bid. This shall be in the form of NEFT/RTGS/B.T. in favour of Zonal

Director Research ARS, Kota, Bank A/C No. 57360100004733, IFSC code: BARB0DHAKAR, bank and branch: Bank of Baroda, Dhakarkhedi, Kota

- (ix) The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for.
- (x) The items shall be sold to the highest price of bidder.
- (xi) The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned after completion of process, except second highest bidder. EMD of second highest bidder will be retained till highest bidder executes the tender.
- (xii) No items, once auctioned to the successful bidder, shall be taken back by ZDR, ARS, Kota.
- (xiii) The successful bidder has to make full balance payment in the form of RTGS/NEFT/B.T. Zonal Director ARS, Kota. Payable at Kota up to 5:00 PM of next working day of auction after confirmation by Email/Fax/post/SMS, failing which the offer may be cancelled and EMD shall stand forfeited.
- (xiv) The successful bidder shall be required to lift all the items from the disposal site within 3 (three) working days after the payment of the quoted amount (EMD amount will be adjusted with the quoted value). On failure to do so, Institution shall have the right to forfeit the entire amount of the bidder and dispose the items to second highest bidder. Bidder shall dully authorize representative to lift items on firm's original letter head.
- (xv) Final decision to accept/reject the bids shall be taken by the Zonal Director, ARS, Kota.

6. Bidding Procedure:

- (i) Bid shall be submitted in the prescribed format in a sealed envelope.
- (ii) Sealed Bids shall be received, not later than 17.07.2025 at 1.00 pm. No Bid will be accepted after this date and time under any circumstances. The office will not be responsible for any postal/ courier delay and also for reasons beyond the control of this office.
- (iii) Bid must be accompanied by a bid security (EMD) of the amount of Rs.68081/- (Rupees Sixty Eight Thousand Eighty One Only) in a form of a NEFT/RTGS/ Bank Transfer in favour of ZDR, ARS, Ummedganj Kota. Payable at Kota Bids without EMD will be summarily rejected.
