Conditions:

1. College has to submit the compliance report of suggestions made by Inspection Committee at the earliest.
2. Future affiliation will be renewed subject to fulfilling the recommendations/conditions suggested by the inspection committee.
3. The intake capacity that is number of girls students to be admitted in the first year of **B.Sc. (Hons.) Agriculture** programme shall not exceed 60 and that the affiliation would be restricted to the academic programme only upto level of under graduate education for the academic session 2024-25. The students shall only be admitted through JET to be conducted by Agriculture University, Kota. After admission is completed, a list of students admitted in **B.Sc. (Hons.) Agriculture** shall be submitted to this University

Suggestions:

1. Timing of library may be increased up to 7.00PM as demanded by students.
2. Roof of the Labs are very low and made up of tin shed which produces intense heat inside the labs and not cordial for working, hence needs to be changed as discussed with management to make these labs more fruitful.
3. Experiential Learning units to be strengthened by-
 - Mushroom unit is small it should be expanded to accommodate 15-20 students.
 - Apiary or honey bee rearing unit may be strengthened by putting more boxes of honey bee colonies including items required for sealing and packing of honey bottles up to marketing.
 - Agriculture waste management unit is situated in low lying area need to be rectified properly.
4. Instructional farm is poorly managed and need to be managed properly by weed management and allotment of lands under different departments.
5. Games and sports facilities are still lacking and should be created.
6. Buildings should be white washed and periphery should be kept clean and weed free.
