**OFFICE ORDER**

In accordance to the inspection report submitted by Inspection Committee, further, approval of the Hon'ble Vice-Chancellor, the temporary affiliation to Government Agriculture College, Hindaun City for the academic session 2024-25 is here by granted subjected to fulfilment of the conditions & Suggestions made by affiliation committee as enumerated below:

**Conditions:**

1. College has to submit the compliance report of suggestions made by Inspection Committee at the earliest.
2. Future affiliation will be renewed subject to fulfilling the recommendations/conditions suggested by the inspection committee.
3. The intake capacity *i.e.*, number of students to be admitted in the first year of **B.Sc. (Hons.) Agriculture** programme shall not exceed 60 and that the affiliation would be restricted to the academic programme only upto level of under graduate education for the academic session 2024-25. The students shall only be admitted through state level entrance exam *i.e.*, JET to be conducted by state Agriculture universities of the Rajasthan.
4. After completion of admission process, a final list of admitted students in **B.Sc. (Hons.) Agriculture** shall be submitted to the Agriculture University

**Suggestions:**

1. Immediate attention is required to develop the instructional farm and establishment of few EL units for implementation to student READY programme in accordance to the recommendation of 5<sup>th</sup> Dean's committee.
2. Urgent need to recruit or appoint faculty of Agriculture.
3. Major agricultural equipment/ instruments should be purchased as earliest possible suggested by committee.
4. Strengthening the library with proper maintenance and facility of internet is required. New and updated books as per list of 5<sup>th</sup> Dean's committee are required. Book bank facilities must be accessible to every student. Separate reading room may be assigned.
