**ORDER**

On the recommendations of the Statutory Selection Committee in reference to interview held on 17.04.2018 and on the decision dated 27.11.2024 of the Hon'ble Rajasthan High Court Bench at Jaipur, and in pursuance of Resolution No. BOM-24/ 2025/ 05 dated 28.01.2025 of the Board of Management, the Vice- Chancellor is pleased to appoint following person as **Subject Matter Specialist (Home Science)** temporarily on probation for a period of two years as Probationer Trainee and post her at the place mentioned against her name on a fixed remuneration of Rs. 39300/- per month in Pay Level L-14 of the Rajasthan Civil Services (Revised Pay) Rules, 2017, without any consequential benefits inclusive of arrears and seniority and other terms and conditions mentioned below:

**Terms and Conditions:**

1. The appointment shall be treated as **fresh appointment** on the aforementioned post without any consequential benefits inclusive of arrears and seniority thereof. The incumbent has to furnish a "Bond" (Annex-I) on a Rs. 100/- non-judicial stamp to this effect.
2. The appointment will be governed by the teachers and officers service and conduct rules of the University.
3. The pay and pension will be admissible as per rules of Government of Rajasthan as amended from time to time and provisions of the funding agency (in case of Plan post) and as adopted by the University.
4. The candidate shall be paid fixed remuneration as per Rajasthan Civil Services (Revised Pay) Rules, 2017; dated 30.10.2017 and no other allowances and/ or annual increment would be admissible during probation period.
5. The pay fixation will be done only after successful completion of two years of probation period on the post of **Subject Matter Specialist** in the pay level L-14 along with admissible pay and other allowances, as per rules.
6. In case of the 'Plan' post, the services would liable to be terminated without any prior notice consequent upon withdrawal of scheme/ post.
7. The appointee will be required to join the post within a period of 'Four' weeks from the date of issuance of this order, failing which the appointment order will be treated as cancelled automatically.
8. The incumbent can be transferred at any place in the University jurisdiction area.
9. The appointee should submit a 'Health Certificate' issued by Government Medical Officer.
10. The appointee should also submit a set of 'self- attested' documents (Marksheets & certificates of exams passed, Caste/ Category certificate, Certificate of marital status, Bonafide residence certificate) etc. at the time of joining of post.
11. If at any stage, any documents or information submitted is/ are found fake/ false, the appointment order of the appointee will be cancelled immediately and the incumbent shall be black listed for getting future employment and the University reserves the right to initiate



- prosecution against the candidate and also has right to recover the amount with panel interest and expenditure already paid to him/ her.
12. During the probation period the candidate will be admissible 15 'Casual Leave' in a calendar year. If the period is less than the calendar year then leave will be payable in proportion to the service period (per month). No deputation allowance shall be payable. However, travelling allowance will be admissible against travelling 'on duty'.
  13. The date of appointment of the candidate will be valid from the date of joining and no traveling allowance will be payable for taking charge.
  14. Candidate is required to submit a bond in prescribed format (Annex-II) on a non-judicial stamp paper of worth Rs. 100/- at the time of joining, giving an undertaking that he/ she will not leave the services of the University within a period of three years from the date of joining. In case the candidate leaves the University services within three years period, he/ she is required to pay a sum of Rs. 3.0 Lakhs (Rupees three lakhs only) to the University.
  15. The candidate is also required to furnish a Affidavit in prescribed format (Annex-III) on a non-judicial stamp paper of worth Rs. 100/- (duly notarized) at the time of joining as per the Notification No. F.7 (1) DOP/ A II/ 95/ Pt; dated 16.03.2023 of Department of Personnel, Government of Rajasthan, Jaipur.

1. That I am not a disqualified candidate for the purpose of appointment according to provisions of Government of Rajasthan, Department of Personnel (A-II) Notification No. F 7(1)DOP/ A-II/ 95/ Pt. dated 16.03.2023, which is as under:

"No candidate shall be eligible for appointment to the service who has more than two children on or after 1.6.2002.

Provided that

- a. The candidate having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he/ she has on 1<sup>st</sup> June, 2002, does not increase.
- b. Where a candidate has only one child from earlier delivery but more than one child are born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children.
- c. While counting the total number of children of a candidate, the child born from earlier delivery and having disability shall not be counted.
- d. any candidate who performed remarriage which is not against any law and before such the remarriage, he is not disqualified for appointment under this sub rule, he shall not be disqualified if any child is born out of single delivery from such marriage.
- e. The provisions of this sub rule shall not be applicable to the appointment of a widow and divorcee woman.
