## DETAILED TERMS AND CONDITIONS

### ➤ Who shall be the probable clients?

- The hall at **Ground floor** shall be leased out to commercial/ public/ private sector /Banks and offices.
- Priority for leasing the hall on the **first floor** may be given to the same bank/office occupying the ground floor, if they apply or any other commercial/public/ private sector bank/office to run their regional/ zonal office or to the post office.

OR

Any Central/ state Govt. organization/ PSU/ FPO/NGO etc. dealing in Agriculture from which the University may collaborate (formally/ informally) in its mandatory activities.

- The **4 shops** shall be rented out to independent agricultural entrepreneurs/FPOs for sale of agriculture inputs or products viz. fertilizers, pesticides, pot plants, agricultural equipment, processed products, dairy products, fruits, vegetables, etc. **except seed.**
- **Lease Period:** - The halls (ground floor & first floor) may be leased out for a period of at least 10 years while the shops for 05 years. The Lessee shall have to agree with a separate lease/rent agreement bond. After completion of lease period, renewal shall be based on new terms and conditions.
- **Termination of Lease:** - If before the stipulated lease period the Lessee wants to vacate the premises, he/ she will give 03 months' notice to the Lessor and vice-versa.
- **Lease Transfer:** - The lessee shall not transfer/alienate or assign the said land or buildings erected there on to any third party in full or in part.

➤ **Rent:**

- The lessee bank/office has to deposit security amount of Rs. 15.0 lakh (separately for ground and first floor halls) and tenant has to deposit 3.0 lakh (for each shop) which will be refundable. However, this condition will not be applicable on the Central/ state Govt. organization/commercial banks etc.
- That the Lessee shall pay the said monthly rent to the Lessor by the 07<sup>th</sup> day of each English calendar month, in advance.
- In case of delay in rent payment, the lessee has to pay Rs. 1000/- penalty for hall and Rs. 500/- for shops every one day beyond 7<sup>th</sup> day of every month.
- The rent of halls and shops shall be **increased by 5% every year.**

- **Mode of awarding the lease/ rent:** The halls and shops shall be leased/ rented out by following open bid system involving two stage bids: Technical Bid and Financial bid. Technical bid should judge the **licensing for banking in Borkhera area**, reputation, paying capacity and usefulness to the University.

➤ **Obligation and Duties of Lessee/ tenant: -**

- The lessee/ tenant shall not vacate the said premises on or before 6 months lock-in-period, if the lessee/ tenant vacates on or before 6 months lock-in-period then the 3-month rent and all other dues (electricity/ water charges, etc.) shall be deducted from security deposit.
- The lessee/ tenant shall comply with all government laws, rules and regulations applicable to the use, development or use and operation of the premises/ property. The lessee/ tenant shall not do or cause any act, deed or thing which may cause nuisance or annoyance to the adjoining sale counter/ halls.
- The lessee/ tenant shall not store any explosive, combustible goods (save and except for the operation of a canteen and/ or a pantry), obnoxious substances, acids, liquor etc.
- That the Lessee/ tenant shall regularly pay the electricity charges, water charges, municipal taxes etc. to the concerned authorities.
- That the Lessee/ tenant has been before occupying the said property that all sanitary and electric fitting and fixtures are in good working condition and is satisfied that nothing is broken or missing and the Lessee/ tenant on vacating

the lease premises shall restore them in the same condition subject to normal wear and tear.

- That the Lessee/ tenant not sublet, assign or part with the possession of the aforesaid rented property in whole or in part under any circumstances.
- That the Lessee/ tenant shall comply with all the rules and regulation of the local authorities.
- That the Lessee/ tenant shall not carry out any addition or alteration in the structure/ property or otherwise under any circumstances.
- That day-to-day repair such as replacement of fuses and elements setting right, leakages in water taps, and/ or any damage to the property or the items fixed resulting by the fault of the lessee/ tenant or its customers etc. are to be carried out by the Lessee/ tenant at his own costs. However, the major repair shall be carried out by the Lessor at his own costs and expenses. The lessee/ tenant shall return the premises and all fixtures in the working condition on expiry of the term of lease with proper satisfaction of the lessor.
- The lessee/ tenant shall keep the interiors of the demised premises including doors and windows thereof in good and tenantable repair condition throughout the lease.
- That the Lessee/ tenant shall permit the Lessor or his agents or representative to enter upon the lease premises for inspection and carry out the repairs etc. at reasonable time as and when necessary.
- That in case, if the period of lease/ rent agreement is extended for further period as mutually agreed between the parties on the terms and conditions as given above then the fresh Lease Deed/ rent agreement shall be executed.
- That in case the Lessee/ tenant fails to vacate and give the physical vacant possession of the said rented property within the said stipulated period, then the Lessee/ tenant shall pay the damages@ Rs 5000/- per day till the possession is given by the Lessee to the Lessor.
